The Rules:

1. Official time begins upon commencement of shooting (bride's preparations, etc.), or one hour prior to the scheduled ceremony (when we setup our cameras, microphones, etc.), whichever is earliest, and time shall run continuously until departing the event location.
2. If the total job time exceeds the time contracted for, extra charges will apply at the rate of \$150/hr (Standard Definition) or \$200/hr (High Definition).
3. In the event of a postponement or cancellation of this contract, so long as a minimum of thirty days notice has been given to Audie Digital Media, the deposits paid may be used for any future event up to one year past the date of this contract, providing Audie Digital Media has no other obligations for the future date. After that time, all deposits will be forfeited to Audie Digital Media. If Client gives less than thirty days notice of cancellation or postponement, a \$100 rescheduling fee will be charged plus trip fees, if any had yet been made. If event is cancelled after Audie Digital Media arrives at location on the date of the rehearsal or event, the deposit and payment of first half of total fee will be considered "earned", but the last half of total will be refunded.
4. Audie Digital Media reserves the right to use the original tapes and/or reproductions for display, promotion, publication or other purposes and client will sign a release for this purpose, otherwise an additional fee of \$500 will be charged.
5. Audie Digital Media takes utmost care with respect to the exposure, sound capture, editing, duplication and delivery of the video products and services offered. However, in the event Audie Digital Media fails to comply with the terms of this contract due to any event or act, Audie Digital Media's liability is limited to the refund of monies paid to Audie Digital Media.
6. Audie Digital Media must receive photos, invitations, music, checklists, and any other materials required for the completion of the production by wedding day. Production may proceed without such materials if not supplied and Client accepts responsibility for the changes in the production as a result.
7. Client warrants that he/she has the legal rights to anything Audie Digital Media will videotape, including photos, music or other materials supplied by the client for use in this video, and that use will be limited to viewing by friends and family.
8. Client will notify photographer that a videographer will be present and that photographer is not to put himself in front of camcorders at any time. (Photographers need only a moment to shoot, but blocking a camcorder for even a second can ruin an entire scene that may not be reshootable).
9. It is recommended that client assign someone to coordinate with Audie Digital Media to ensure that people and events most important to client are covered.
10. The Client has had opportunity to critically view samples of Audie Digital Media's video work and has retained Audie Digital Media as the exclusive official videographer to cover this event. The Client grants Audie Digital Media full production and editorial control regarding all aspects of this production and postproduction. Client may request one set of changes, upon receiving the approval copy. If such changes require more than one hour of editing time, such extra time shall be billed at \$150 per hour. Such changes must be requested within 72 hours of receipt of approval video.
11. Audie Digital Media reserves the right to remove themselves and all equipment at any time there appears to be a potential danger to themselves or equipment (belligerent or intoxicated people; improper fireworks; careless discharge of firearms; etc.). No refund or other consideration shall be given in such cases. Also, Audie Digital Media agrees to work only in non-smoking environments.
12. Travel to events outside of Lowndes County billable at \$75 per hour. Event's requiring air travel and overnight stays will be quoted on a case by case basis.

Wedding Packages:

The Ceremony: \$800.00

We attend the rehearsal the day before, to observe and plan the shoot. The day of the wedding we arrive one hour before the ceremony starts and setup our equipment. We start shooting before the wedding begins and shoot continuously until the parents of the bride and groom leave the church.

This Package Includes:

- One videographer's coverage of your event using a professional 3-chip camera.
- 2 hours coverage of the Pre Ceremony and the Ceremony.
- 3 hours of post-production in our Digital Non Linear Editing Suite.
- Finished and fully edited video including basic DVD Navigation.
- 2 copies of the DVD in hard cases.

The Event: \$1700

The ceremony is shot as described above. Then we attend your reception and capture the traditional activities such as cake cutting and toasts along with candids of you and your guests. We edit the highlights of the reception into a separate short feature on your DVD including: graphics, stills and music where appropriate.

This Package Includes:

- One videographer's coverage of your event using a professional 3-chip camera.
- Up to 5 hours coverage of the event including: Ceremony, Reception, and Bride/Groom Departure.
- 10 hours of post-production in our Digital Non Linear Editing Suite.
- Incorporation of still images: Invitation Card and up to 15 childhood and/or dating photos
- Special effects (animated transitions, B&W, slow motion, etc.)
- Finished and fully edited video including menu driven DVD Navigation.
- 4 copies of the DVD in hard cases with color printing

The Story: \$2600

The event is shot as described above. We produce a photo montage using your photos and music (Up to 50 images & 5 minutes runtime). We shoot one additional event of your choice: rehearsal dinner, shower, bridal/groom parties, etc... We can prepare the photo montage ahead of time to show at the reception and/or the rehearsal dinner.

This Package Includes:

- One videographer's coverage of your event using a professional 3-chip camera.
- Up to 8 hour video coverage.
- 16 Hours of post production.
- Coverage of Bride and Groom preparation.
- Video photo session in the church or outdoors.
- Recap Short Feature of the entire day's highlights.
- Guest Interviews: Well wishes and stories about the couple by their important family and friends.
- 8 copies of the Dual-Layer DVD in hard cases with color printing.

We cannot keep huge video files on our computer longer than 14 days from the time we send your approval copy, so if changes are requested after that time, extra editing charges will apply.

Outdoor Weddings:

Audie Digital Media utilizes proper equipment to reduce wind noise and camera rain covers in the case of a drizzle or light rain, however Audie Digital Media reserves the right to immediately remove all equipment to an indoor location in the event of weather that may be hazardous to equipment or persons. No refund or reduction in price shall occur in this event, but hopefully you would move the event indoors where we could continue our work. Clients are advised that direct sunlight is not good for video or photos of people and that lighting conditions are best either in the two hour period prior to sunset or the two hour period following sunrise.
